ARTICLE I. NAME

The name of this corporation is Brickell Key Tours & Transportation, Inc.

ARTICLE II. NATURE OF THE BUSINESS.

The general nature of this business to be transacted by this corporation is any legal business in the State of Florida or in the United States.



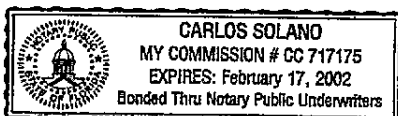


