ARTICLE I

EFFECTIVE DATE

ARTICLE II

<u>Purpose</u>

Bylaws

though it had been authorized at a meeting of the Board of Directors.

Calling of Special Meetings

Special meetings of shareholders may be called by any member of the Board of Directors.

ARTICLE XIII

<u>Amendments</u>
