ARTICLES OF INCORPORATION
OF
K. G. BAJAJ, M.D., P.A.

The undersigned, being a duly licensed physician in the state of Florida, for the purpose of forming a professional corporation under Chapter 607 of the Florida Statutes, and Chapter 621 of the Florida Statutes, being the Professional Service Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be:

K. G. BAJAJ, M.D., P.A.

The principal place of business of this corporation shall be 2819 A. STONEMAN LANE FT. PIERCE, FL 34982.

ARTICLE II. NATURE OF BUSINESS

The sole specific purpose for which this corporation is organized is to practice the profession of medical services; provided, however, that this Article shall not be construed so as to limit the provisions of Section 621.08, Florida Statutes 1987.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having \$1.00 par value per share.

ARTICLE IV. ADDRESS

The street address of the initial registered office of the corporation shall be 2819 A. STONEMAN LANE FT. PIERCE 34982. The name of the initial registered agent of the corporation at that address is K. G. BAJAJ, M.D..

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI. PREEMPTIVE RIGHTS

Every shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof at the price at which it is offered to others.
