ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF LAKE NONA GOLF PROPERTIES, INC.

Pursuant to the provisions of Sections 607.1002 and 607.1006 of the Florida Statutes, LAKE NONA GOLF PROPERTIES, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:
