

ARTICLES OF INCORPORATION OF



The undersigned, acting as the incorporators of a corporation under the Florida General Corporation Act and pursuant to Chapter 607 of Florida Statutes, adopt the following Articles of Incorporation:

I. NAME:

The name of the corporation shall be: Lamb Island Beef Cattle, Inc.

II. **TERM OF EXISTENCE:**

The corporation shall have a perpetual term of existence beginning upon the filing of the Articles of Incorporation by the Department of State.

III. THE PURPOSE:
