The undersigned, acting as the incorporators of a corporation under the Florida General Corporation Act and pursuant to Chapter 607 of Florida Statutes, adopt the following Articles of Incorporation:

I.

NAME:

The name of the corporation shall be: **Lamb Island Beef Cattle, Inc.**

II.

TERM OF EXISTENCE:

The corporation shall have a perpetual term of existence beginning upon the filing of the Articles of Incorporation by the Department of State.

III.

THE PURPOSE:

The corporation shall initially and specifically engage in selling livestock, and may engage in the transaction of any or all other lawful business for which corporations may be incorporated under the Florida General Corporation Act (Chapter 607, Florida Statute).

IV.

CAPITAL STOCK

The corporation shall have the authority to issue One Hundred (100) shares of capital stock, which shall consist solely of common stock at a par value of One Dollar (\$1.00) per share.




