ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Act, adopts the following Articles of Incorporation for such Corporation.

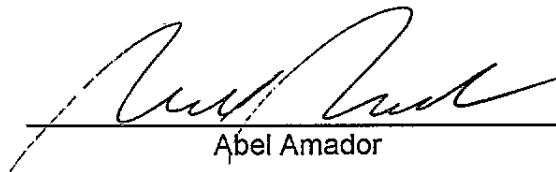

The preemptive right of any holder is determined by the ratio of the authorized (authorized and issued) shares of common stock held by the holder to all shares of common stock currently authorized (and issued).

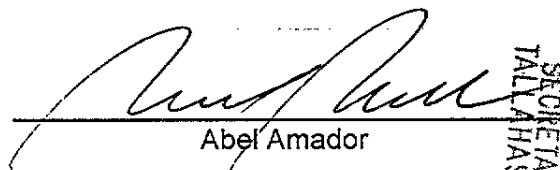
