ARTICLES OF INCORPORATION OF JOYCOL ELECTRONICS, INC.

THE UNDERSIGNED INCORPORATOR to these Articles of
Incorporation is a natural person competent to contract and form
a corporation under the laws of the State of Florida, and does
certify that he has become a corporation under and pursuant to
the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is JOYCOL ELECTRONICS, INC.
The principal place of business of this corporation shall be 1554

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
