ARTICLES OF INCORPORATION OF

CENTER LINE MACHINE, INCORPORATED



ARTICLE I

NAME

The name of this corporation is CENTER LINE MACHINE, INCORPORATED

ARTICLE II

EFFECTIVE DATE

The date of the commencement of the corporate existence shall be the date of the filing of these Articles with the Secretary of State.

ARTICLE III
