THE UNDERSIGNED SUBSCRIBERS to these Articles of Incorporation, each a natural person component to contract, hereby associated themselves together to form a corporation under the laws of the State Of Florida.

ARTICLE I

This corporation may engage in the transaction of any and all lawful business for which corporations may be incorporated under Florida Law.


