The undersigned hereby make, subscribe and acknowledge these Articles of Incorporation in order to organize and incorporate a business for profit under the laws of the State of Florida Statues, Chapter 607.

ARTICLE I - NAME

EFFECTIVE DATE

The name of the corporation is PRO CAD DRAFTING SERVICES INC.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business is to provide CAD drafting to business and individuals.

ARTICLE III - DURATION & EXISTENCE

B. Unless otherwise provided in the By-laws, no stockholder shall have a pre-emptive right to purchase his/her pro rata share of new stock.


C. Unless otherwise provided in the By-laws, cumulative voting shall not be permitted.


