Name

The name of the corporation is REPEAT CONSULTING & VENTURE CAPITAL, INC.



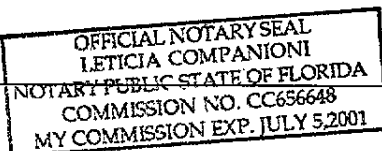
