

Articles Of Amendment

Pursuant to Section 607.1006, Florida Statutes – "Articles of Amendment" — The American Connemara Arts Foundation, Inc. hereby amends its articles of incorporation and sets forth the following in these articles of amendment:

- (a) The name of the corporation: The American Connemara Arts Foundation, Inc.
- (b) The text of the amendment adopted is as follows: Article I and Article IV are amended in their entirety and Article VII is added, as follows, respectively:

CP OF PROPERTY OF STREET, STRE

ARTICLE I - NAME AND MAILING ADDRESS

The name of this corporation is Williams Consulting Group, Inc. and the mailing adjacorporation is 2503 W. Gardner Ct.; Tampa, Florida 33611.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue Fifty Million Shares of One Cent par value common stock, which shall be designated as "Common Shares" and Twenty Million Shares of One Cent par value preferred stock, which shall be designated as "Preferred Shares."
