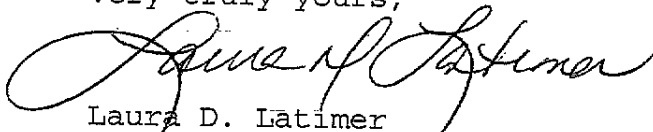

- 2) Article IV shall be amended to read as follows:

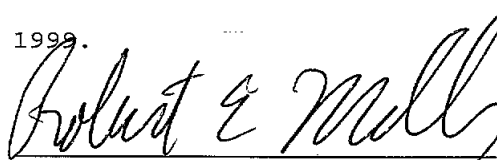
ARTICLE IV

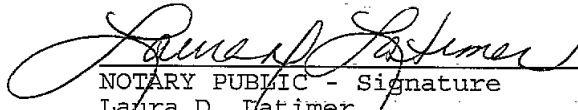
