ARTICLES OF INCORPORATION

The undersigned incorporator makes, acknowledges, and files with the Department of State of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I Name and Address

The name of this corporation shall be Genesis Enterprises, Inc., and its principal place of business shall be 1242 Shelter Rock Rd., Orlando, Florida, 32835; but it may establish branch offices at any other points deemed advisable by its board of directors within the State of Florida.

ARTICLE II Term of Existence

This corporation shall have a perpetual existence.

ARTICLE III Nature of Business

The maximum number of shares of stock that this corporation is authorized to have at any one time is ONE THOUSAND (1000) shares of common stock, having no par value.


