ARTICLES OF INCORPORATION
OF

The undersigned acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of this corporation is PREMIER AIRPORT SHUTTLE SERVICE, INC.

DURATION
