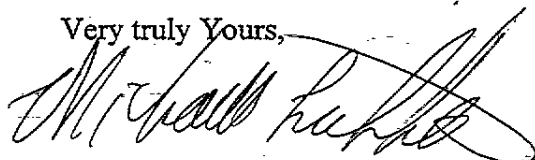

**ARTICLES OF INCORPORATION
OF
EMPIRE AIR CONDITIONING, INC.**

ARTICLE I. NAME

The name of this corporation is: Empire Air Conditioning, Inc.

ARTICLE II. DURATION

This Corporation shall exist perpetually.

ARTICLE III. PURPOSE

To engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV. CAPITAL STOCK

This Corporation is authorized to issue Fifty Thousand (50,000) shares of One Dollar par value common stock which shall be designed "Common Shares".

ARTICLE V. VOTING RIGHTS

ARTICLE XI. RESTRICTIONS ON THE TRANSFER OF STOCK

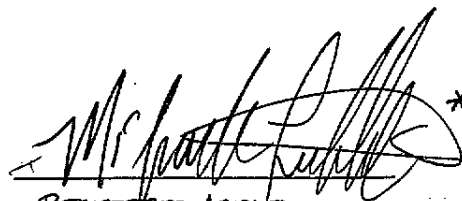

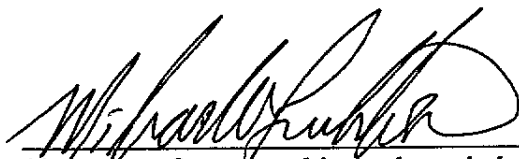
ARTICLE XII. AMENDMENT

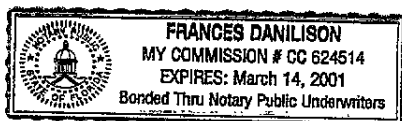
