ARTICLE I

The name of this corporation is **SCOTTCO TECHNOLOGIES, INC.**

ARTICLE II

ARTICLE III

This corporation is authorized to issue seven thousand five hundred (7,500) shares of One (\$1.00) par value of common stock.


