

ARTICLES OF INCORPORATION

OF

VIRTAC, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I CORPORATE NAME

The name of the corporation is:

VIRTAC, INC.

ARTICLE II DURATION

This corporation will exist perpetually unless dissolved according to Florida law.

ARTICLE III PURPOSE

To engage in the sales and service of products and equipment to the retail industry and the general public, and the doing of any other business and sales or contracting work incidental to or connected with such work.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissable lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.


