I AM WRITING THIS LETTER REQUESTING THE LATE FILING FEE BE WAIVED ON MY 1999 CORPORATE ANNUAL REPORT DUE TO EXTENUATING CIRCUMSTANCES WHICH ARE AS FOLLOWS. DECEMBER 6 1998 I SUFFERED A HEART ATTACK, DECEMBER 10 I HAD TRIPLE HEART BY-PASS SURGERY. WHEN I FIRST GOT THE NOTICE I DID NOT HAVE THE MONEY TO PAY IT. SINCE THEN

I AM BACK TO WORK AND THE BUSINESS IS DOING WELL HOWEVER I GOT BEHIND IN

~~EVERY~~ EVERY THING AND I FORGOT ABOUT THE REPORT. I CAN DOCUMENT THESE EVENTS IF NEEDED. YOUR COOPERATION IN THIS MATTER WOULD BE GREATLY APPRECIATED.
