ARTICLES OF INCORPORATION

OF

NORTHEAST FLORIDA ALPHASE CONTRACTING, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is Northeast Florida Alphase Contracting, Inc.


