ARTICLES OF INCORPORATION

OF

HOMAN AND ASSOCIATES, INC.

PALLAHASSEE FLORIDE

PAUL M. HOMAN and ROSELLA G. HOMAN, the undersigned, hereby associate HOMAN AND ASSOCIATES, INC. for the purpose of becoming a corporation for profit under the laws of the State of Florida, and do certify that HOMAN AND ASSOCIATES, INC.. has become such corporation under and pursuant to the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be: HOMAN AND ASSOCIATES, INC.

# ARTICLE II

The general nature of the business to be transacted and carried on by this corporation and its object and purpose is: To transact any and all lawful business regardless of its nature or description.

## ARTICLE III

The maximum number of shares which this corporation shall be authorized to issue and have outstanding at one time shall be limited to One Hundred (100) shares of common stock, Ten Dollars (\$10.00) par value.

The consideration for the issuance of such shares of stock, or any part thereof, shall be money current of the United States of America, or property or services of value at least equivalent of Directors of this corporation at any meeting of the Board. The corporation shall begin business with paid in capital of not less than Five Hundred Dollars (\$500.00).
