The undersigned Incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

**ARTICLE I**

**Name**

The name of the corporation shall be Pinsonic Investments, Inc.

**ARTICLE II**

**Principal Office**

The principal office of the Corporation is located at 316 Harlequin Court, Oviedo, FL 32765

**ARTICLE III**

**Corporate, Purpose, Power and Rights**




