ARTICLE I - NAME

The name of the corporation is NU LINE AUTO TRANSPORT, INC.

ARTICLE II - DURATION




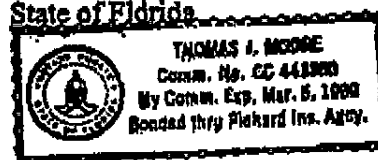
