SECOND: This amendment was adopted by the undersigned, being the sole incorporator. The date of adoption is July 1, 1998.

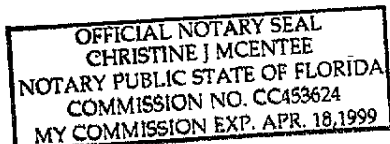
THIRD: No shares in this corporation have been issued and, therefore, shareholder action was not required.
