ARTICLES OF INCORPORATION OF Injury Care Centers of South Florida, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the Corporation is Injury Care Centers of South Florida, Inc.

ARTICLE TWO

The duration of the Corporation is perpetual.

ARTICLE THREE

The general purposes for which the Corporation is organized are:

- To provide comprehensive medical care and treatment.
