ARTICLE I. NAME

The name of the corporation shall be: Collier Jacksonville One, Inc.

ARTICLE II. NATURE OF BUSINESS

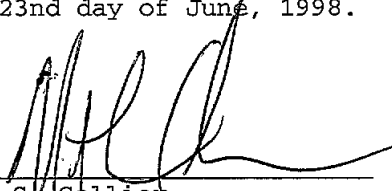

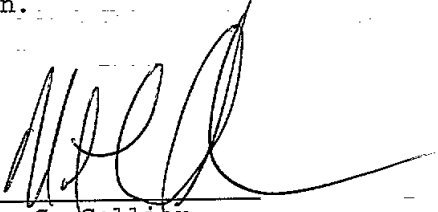
