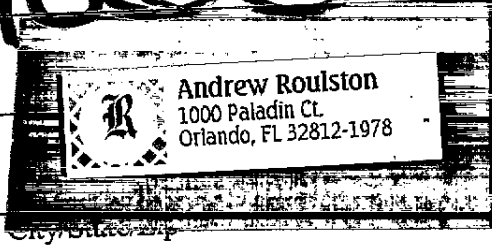

Know All Men By These Presents: That the undersigned incorporator does hereby incorporate a corporation under the provisions of Chapter 607, Florida Statutes, for the transaction of business with and under the following Articles of Incorporation:

Article I

The name of the corporation shall be and is **Arconsult Inc.**
