The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act,  
adopts the following Articles of Incorporation for such corporation:

1. The name of the Corporation is: SUNDO, Inc.
2. The period of its duration is perpetual.
3. The purpose is to engage in any activities or business permitted under the laws of the  
United States or Florida.
4. The corporation shall have authority to issue 100 shares, all of one class, at \$1.00 par  
value.

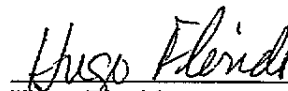
