FIRST: The name of this corporation is:

ISLE OF PALMS MARINE SERVICE, INC.

SECOND: The general nature of the business to be transacted is the repair, maintenance, purchase and sale of boats and other water craft, ownership and operation of docks and marinas and to transact any lawful business and to exercise all powers granted to corporations by the laws of the State of Florida.

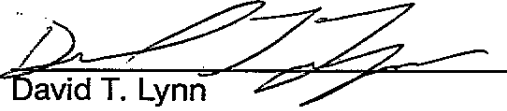

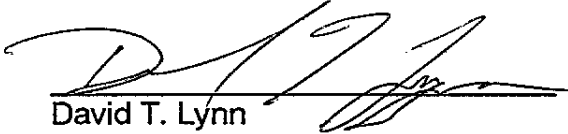
