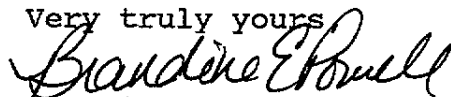

- ARTICLE I: The name of this corporation is **BNS Management, Inc.**
- ARTICLE II: The existence of the corporation shall begin on June 25th, 1998.
