Notice of the winding-up proceedings of the corporation was mailed by certified mail to each municipality in which the corporation has a principal or registered agent.

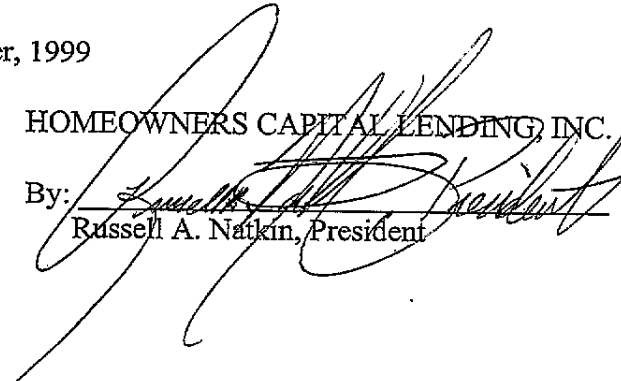
