ARTICLES OF INCORPORATION

ARTICLE I

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

THE NAME OF THIS CORPORATION SHALL BE HURDLING AROUND THE
WORLD, INC.

ARTICLE II

THE INITIAL ADDRESS OF THE CORPORATION'S PRINCIPAL OFFICE SHALL

ARTICLE III

CONDUCTING BUSINESS.

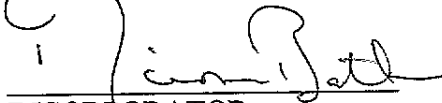

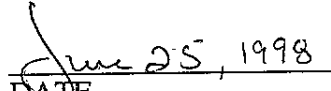
