The undersigned, acting as Incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. **Name.** The name of this corporation is CHARLES G. WEBB, INC. and the mailing address is 491 Keenan Court, Fort Myers, Florida 33919.

2. **Duration.** The period of its duration is perpetual, except as the same may be dissolved as provided by law.
