The Undersigned for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

# ARTICLE ONE

NAME

The name and principal address of the corporation is SALVAGE CITY AUTO PARTS, INC., at Suite 492, 1489 W. Palmetto Park Road, Boca Raton, FL 33486.

# ARTICLE TWO

## DURATION

The term of existence of the corporation is perpetual.

# ARTICLE THREE

# PURPOSE

The corporation may transact any and all lawful business for which corporations may incorporate under the Florida General Corporation Act.

## ARTICLE FOUR

#### CAPITAL STOCK
