

ARTICLES OF INCORPORATION

OF

QUADRA FINS STABILIZER, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation.

ARTICLE ONE

NAME

The name of the corporation is QUADRA FINS STABILIZER, INC., and the street address of its initial principal office is 2981 S. E. Dominica Terrace, Stuart, Florida 34997.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual commencing on the date of the filing of these Articles of Incorporation by the Department of State of the State of Florida.

ARTICLE THREE

PURPOSE

This corporation is organized so it may transact any and all lawful business.

ARTICLE FOUR

CAPITAL STOCK

The aggregate number of shares which the corporation had authority to issue is 10,000, all of which shall be common shares with a par value of \$1.00.
