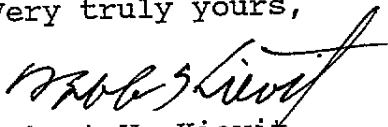

ARTICLES OF INCORPORATION

OF

LINDA M. McDADE, C.R.N.A., P.A.

The undersigned incorporator, Linda McDade, in order to form a professional service corporation for the practice of nurse anesthesia under the provisions of Chapter 621, Florida Statutes, the "Professional Service Corporation and Limited Liability Company Act", hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be LINDA M. McDADE, C.R.N.A., P.A.

ARTICLE II. PURPOSE

The corporation is organized for the purpose of engaging in the practice of nurse anesthesia. The professional services involved in the practice of nurse anesthesia by the corporation may be rendered only through officers, agents and employees of the corporation who are duly authorized and licensed to provide such services in the State of Florida.

The corporation shall not engage in any business other than the practice of nurse anesthesia. However, the corporation may invest its funds in real estate and in other types of investments and may own real and personal property necessary for the rendering of such services.

ARTICLE III. PRINCIPAL OFFICE

The initial principal office of the corporation shall be located at, and the mailing address of the corporation shall be, 308 Fort Pickens Road, Pensacola Beach, Florida 32561.

ARTICLE IV. TERM OF EXISTENCE

The corporation is to exist perpetually commencing on the filing of these Articles of Incorporation by the Secretary of State.

ARTICLE V. CAPITAL STOCK

The corporation is authorized to issue 7500 shares of One Dollar (\$1.00) par value common stock. The stock of the corporation shall be issued only to and may be transferred only to persons who are duly licensed to practice nurse anesthesia in the State of Florida.

ARTICLE VI. INITIAL REGISTERED AGENT AND ADDRESS

The initial registered agent of the corporation is the law firm of KIEVIT, KELLY & ODOM, P.A., 15 West Main Street, Pensacola, Florida, 32501.

ARTICLE VII. INCORPORATOR

The name and street address of the incorporator to these Articles is Linda McDade, 308 Fort Pickens Road, Pensacola Beach, Florida 32561.

ARTICLE VIII. DIRECTORS


The corporation shall initially have one director. The number of directors may be increased or decreased from time to time by the bylaws, but shall never be less than one. The initial director of

the corporation shall be Linda McDade, whose address is 308 Fort Pickens Road, Pensacola Beach, Florida 32561.

ARTICLE IX. AMENDMENT

The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.
