The period of duration of the Corporation shall be perpetual commencing on the date of execution and acknowledgment of these Articles.


**ARTICLE FOUR

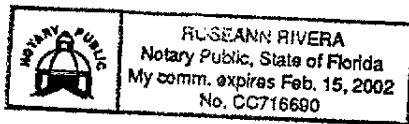


