ARTICLES OF INCORPORATION

The undersigned Incorporator to these Articles of Incorporation, competent to contract, hereby forms a for profit corporation under Chapter 607 of the Florida Statutes and other applicable laws.

ARTICLE ONE: The name of the Corporation is HOME DESIGNERS, INC.

ARTICLE TWO: The period of the Corporation is perpetual.

ARTICLE THREE: The nature of the business to be transacted by this Corporation is to provide services in connection with architectural plans and home designs and all related services thereto through its officers, employees and agents.

ARTICLE FOUR: Authorized Shares.

- (a) Number: The aggregate number of shares that the Corporation shall have the authority to issue and have outstanding at any one time is 7,500 shares of capital stock with a par value of \$1.00 per share.
