## ARTICLES OF DISSOLUTION OF LIGHT GAGE STEEL SYSTEMS, INC.



Pursuant to the provisions of Sections 607.1402 and 607.1403 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Dissolution:

#### ARTICLE I - NAME OF CORPORATION

The name of the corporation is Light Gage Steel Systems, Inc. (hereinafter referred to as the "Corporation").

## ARTICLE II - DATE DISSOLUTION AUTHORIZED
