FOR

ARTICLE I
NAME

The name of this corporation is NEW PERSPECTIVE ENTERPRISES, INC..

ARTICLE II
PURPOSE

This corporation is organized for the purpose of engaging in and transacting any and all lawfull business permitted under the laws of the United States and the State of Florida.

ARTICLE III
CAPITAL STOCK

The amount of capital stock authorized by these Articles of Incorporation, being the maximum shares of capital stock which the corporation is authorized to issue and have outstanding at any time shall be One thousand (1000) shares of common stock.
