- 1. NAME. The name of this corporation is: Precision Spraying, Inc.
- 2. DURATION. The period of its duration is: Perpetual
- 3. PURPOSE. The Corporation is being organized for the transaction of any and all lawful business permitted under the Florida General Corporation Act and the Laws of the United States.

This right may also be waived by affirmative written waiver submitted by the shareholder to the Corporation within thirty (30) days of receipt of notice from the Corporation.
