ARTICLES OF INCORPORATION

- Profit Corporation -

The undersigned, desiring to form a corporation, for profit, does hereby state the following:

FIRST: The name of the corporation shall be:

Ed's Racks, Inc.

SECOND: The place in the State of Florida where

its principal office is to be located is:

THIRD: The purpose for which this corporation is formed is to engage in any lawful act or activity.
