The initial registered office of this corporation is located at: 3665 West King St., Cocoa, Florida 32926. The name of the Registered Agent at such address is David B. Smith.

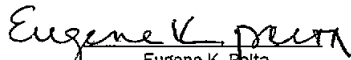

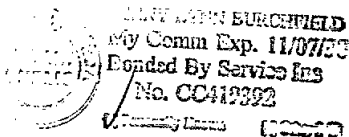

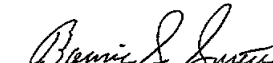
