**ARTICLES OF INCORPORATION**  
**of**  
**ROBERT CORBETT MOBILE HOME CENTER, INC.**  
**a Florida corporation**

We, the undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida pursuant to the provisions of the applicable Florida Statutes:

**ARTICLE I - CORPORATE NAME**

The name of this Corporation shall be ROBERT CORBETT MOBILE HOME CENTER, INC., a Florida corporation.

**ARTICLE II - NATURE OF CORPORATE BUSINESS**

This corporation, through its officers and employees, shall be authorized to buy, sell, re-sell, lease, own, rent, market, exhibit, mortgage, assign, transfer, quit-claim, and convey mobile homes, mobile home parts and/or accessories, and other merchandise, either retail or wholesale, real and personal property; and participate in all other activities which may be necessary to the operation of such business.

**ARTICLE III - CAPITAL STOCK**

This corporation shall be authorized to have a maximum of 100 shares of stock outstanding at one time. The shares of stock authorized shall be common stock having a par value of One Dollar (\$1.00) per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.

**ARTICLE IV - INITIAL CAPITAL**

The amount of capital with which this corporation shall begin business shall be no less than One

Hundred Dollars (\$100.00).

#### **ARTICLE V - TERM OF EXISTENCE**

This corporation shall have a perpetual existence.
