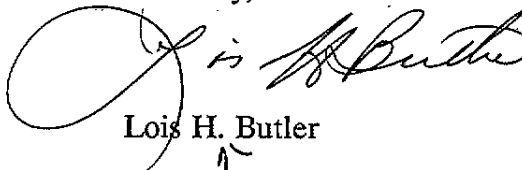

ARTICLES OF INCORPORATION  
OF

ARTICLE I - NAME

The name of the corporation is VISIONS-MIAMI, INC. hereinafter called the "Corporation")
