#### ARTICLES OF INCORPORATION

#### ARTICLE I. Name and Initial Address

The name of this corporation is NIKOLAI ENTERPRISES, INC. and initial address of the corporation is 4753 North Tamiami Trail, Naples, Florida 34103.
