

The undersigned hereby subscribe to these Articles of Incorporation to form a corporation under the laws of the State of Florida.

T.

The name of the corporation is AFFORDABLE JEWELRY AND PAWN, INC.

II.

This corporation is organized for the purpose of buying, selling, and merchandising articles of all types; of operating one or more pawn shops, jewelry shops, retail, and wholesale stores; of buying and selling motor vehicles, and for the purpose of the transaction of any or all lawful business for which corporations may be incorporated under Florida Statutes, Chapter 607.


