## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF AUTOCOUNT, INC.



Pursuant to the provisions of Section 607.1006, Florida Statutes, AUTOCOUNT,

INC. (the "Corporation") adopts the following articles of amendment to its Articles of Incorporation:

FIRST: Article 4 - Capital Stock is amended to read as follows:

### ARTICLE 4 - CAPITAL STOCK

The maximum number of shares this Corporation is authorized to issue is 2,000,000 (Two Million) shares, no par value per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

SECOND: The date of adoption of the amendment is December 31, 2002.

**THIRD:** The shareholders approved the amendments. The number of votes cast for the amendments were sufficient for approval.
