CERTIFICATE OF INCORPORATION

OF

WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of becoming a corporation under the Laws of the State of Florida, by and under the provisions of the Statutes of the said State of Florida.

ARTICLE I

The name of this corporation shall be:

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.






